Please note: New licensing System Training

It is important for everyone to take the new licensing portal training. There have been a number of submissions of continuing education that haven't been completed correctly and it is creating some issues in the system.

Upcoming training dates and the zoom links are on the next page. Each session is limited to 100 participants.

Additional sessions will be added if there is a demand.

New Licensing Portal

Portal Setup

The first step to accessing the new portal is creating your password. If you have not yet created your password, please do so as soon as possible. **The username and password for the old portal is no longer valid.**

- To create your password, go to the AFSRB website (www.afsrb.ab.ca) and click on licensee login and then the account setup button.
- Enter your username: first initial, middle initial and full last name, lowercase and no spaces. If you do not have a middle name in the system, there will be no middle initial in your username.
- Enter your email (the email this newsletter was delivered to)
- Press 'submit and continue' and follow the steps to create your password using the required format

Features for the new portal:

- One login allows access to individual portal and all business locations for business managers.
- Applicants complete forms and upload documents in their portal for business manager approval
- Declarations can be completed electronically within the portal
- All payments are made in the portal by credit card, including exam fees and fees for pre-need salesperson courses.
- Annual business reporting documents and declarations are now submitted in the portal
- Mandatory course video and live session registration are available on the portal.

2024-25 Continuing Education

Continuing education requirements for all licensees are 3 self directed credits every year. Once every three years there is also a mandatory course determined by the AFSRB that all licensees are required to take. There is a mandatory course to be completed in 2024-2025. See reminders below:

Anyone licenced between **April 1, 2024—March 31, 2025** is responsible for fulfilling the CE requirement regardless of when you became licensed

- Credits <u>cannot</u> be carried forward from a previous year
- Sessions/activities/courses must be completed between April 1, 2024 and March 31, 2025.
- Repeated courses/sessions/activities must not be claimed more than once
- Students who become fully licensed within the year can use credits from their formal education.
- <u>Self-directed</u> credit hours are education activities that you choose to participate in
- When entering education into your portal, follow the instructions on the form

2024-25 Mandatory Course

The mandatory continuing education course for the 2024 – 2025 fiscal year is: **Navigating Compassion Fatigue and Burnout: Staying Grounded While Supporting Others**. This course was developed by Francoise Mathieu who is the TEND Executive Director. As this is a cost share, each participant is required to pay \$50 at the time of registration. Registration and payment must be made individually. Group payments and registration are not available.

This course has three parts:

- **an on-demand 2 hour webinar** provided by Francoise that can be watched at a time convenient for you. The link to this webinar is available on your portal.
- a one hour mandatory live webinar on Zoom. Every licensee is required to sign up for and attend one of these sessions. Students are welcome.
- **electronic resources**—will be sent upon registration for the live session.

Please Note:

- ⇒ The zoom link will be sent out prior to the live session you registered for
- ⇒ Students and licensees who become licensed before March 31 are required to complete the mandatory course
- ⇒ The 2 hour webinar must be viewed prior to attending the 1 hour live zoom session
- ⇒ Access to the pre-recorded webinar and the link to register for the live session is available through your individual portal under the continuing education heading.
